A. Vertical Reservations:

I. Economically Weaker Section (EWS) of General Category	- 10%
II. Other Backward Classes (OBC) if they belong to Non-Creamy Layer (NCL)	- 27%
III. Scheduled Castes (SC)	- 21%
IV. Scheduled Tribes (ST)	- 2%

B. Horizontal Reservations:

I. Persons with Disability (PwD) (minimum 40% disability)	- 5%
II. Freedom Fighter	- 2%
III. Ward of Military personnel	- 5%
IV. Female Candidate	- 20%
